As emerging technologies transform policing, surveillance, forensic practices, and the administration of justice, the conference seeks to critically explore the normative foundations, institutional dynamics, behavioural shifts, and social consequences of these developments. It provides an interdisciplinary platform for criminologists, psychologists, legal scholars, forensic experts, and digital governance specialists to engage with questions of criminalization, rights, accountability, and community resilience. Through its five thematic tracks, the conference aims to foster grounded dialogue, advance research, and contribute to a more just, transparent, and ethically informed criminal justice landscape in the digital age.

CALL FOR PAPERS

The Organising Committee invites original research papers, theoretical contributions, empirical studies, case analyses, policy critiques, and interdisciplinary work aligned with the conference theme and tracks. Submissions are welcome from criminologists, legal scholars, psychologists, sociologists, forensic specialists, data scientists, digital-governance experts, and professionals working within criminal justice institutions.

Papers may address doctrinal questions, socio-legal insights, behavioural analyses, technological concerns, or policy recommendations relevant to the broader theme of criminalization in a digital age.

Theme:

The Security State and Digital Governance: Rethinking the Architecture of Criminalization

CONFERENCE TRACKS

The conference will be organised across five thematic tracks:

Track I: Rethinking Criminalization, Due Process, and Penal Power

This track explores the conceptual and doctrinal foundations of criminalization, the limits of state coercion, and the erosion of due process through reverse onus clauses, strict liability, and preventive detention. It also analyses overcriminalization, mass incarceration, and the political rise of penal populism.

Track II: Digital Governance, Algorithmic Control, and Tech-Mediated Criminal Justice

This track investigates how AI-driven tools, predictive analytics, biometric systems, and digital surveillance architectures reshape policing, adjudication, and sanctions. It examines the constitutional, ethical, and governance challenges posed by technologically mediated security regimes.

Track III: Criminological and Psychological Perspectives on Digital Societies

This track brings theoretical and behavioural insights into dialogue, addressing cyberpsychology, online radicalisation, risk behaviour, disinhibition, and new criminological models for explaining deviance and control in digital contexts.

Track IV: Forensics, Evidence, and Investigative Practices in the Digital Age

Focusing on forensic science and policing, this track engages with digital forensics, AI-assisted evidence analysis, chain-of-custody challenges, biometrics, and the growing complexities of evidence admissibility in tech-driven investigations.

Track V: Victimology, Community Resilience, and Decolonising Justice

This track centres victim experiences in online and hybrid spaces, including digital stalking, privacy harm, and trauma. It also develops community-led, restorative, and decolonial responses to technologically mediated harms, offering alternatives to punitive digital control.

CONFERENCE SUB-THEMES

1. Foundations and Limits of Criminalization

This theme explores principled criminalization, normative boundaries of state punishment, and the structural forces driving overcriminalization. It invites reflections on how digital governance reshapes decisions about what conduct the state chooses to criminalise or decriminalise.

2. Due Process, Presumptions, and Evidentiary Standards

This theme examines the erosion of liberal safeguards through reverse onus clauses, strict liability regimes, and shifting burdens of proof. It also considers wrongful convictions and systemic failures that undermine the presumption of innocence.

3. Overcriminalization, Selective Enforcement, and the Expansion of Penal Power

This theme studies how criminal law proliferates through legislative excess, regulatory expansion, and administrative shortcuts. It analyses how digital technologies intensify surveillance and widen the net of criminalization, often producing discriminatory outcomes.

4. Carceral Governance and Mass Incarceration

This theme focuses on preventive detention, prison overcrowding, and the political pressures driving punitive policies. It invites empirical and theoretical work on how digital tools reinforce custodial control and contribute to mass incarceration.

5. Penal Populism and the Security State

This theme examines the rise of punitive public sentiment, political rhetoric, and media-driven fear that legitimises harsh criminal justice responses. It analyses how digital platforms amplify populist narratives and shrink the space for rights-based governance.

6. Digital Governance, Algorithmic Policing, and Tech-Mediated Criminalization

This theme addresses the role of AI, predictive analytics, and automated decision-making in reshaping policing, risk assessment, and sanctions. It encourages critical engagement with the opacity, bias, and democratic implications of algorithmic governance.

7. Criminological Theory and Contemporary Control Mechanisms

This theme invites criminologists to revisit classical and contemporary theories such as actuarial justice, risk society, cultural criminology, space transition theory, to explain emerging forms of digital control. It asks how legitimacy, authority, and deviance shift in technology-driven environments.

CONFERENCE SUB-THEMES

8. Psychology, Behaviour, and Digital Environments

This theme explores cyberpsychology, online disinhibition, radicalisation, and behavioural manipulation in digital spaces. It also considers the psychological consequences of surveillance, stigma, and wrongful digital accusations.

9. Forensic Science, Evidentiary Technologies, and Reliability of Proof

This theme addresses developments in digital forensics, biometrics, and AI-assisted evidence analysis. It welcomes debates on admissibility, error rates, chain of custody, and the ethical limits of emerging forensic tools.

10. Policing, Investigations, and Technological Transformation

This theme analyses smart policing systems, body-worn cameras, encrypted communication, and real-time surveillance architectures. It invites empirical and doctrinal studies on how technology is reshaping investigative capacities and institutional accountability.

11. Victimology, Digital Harms, and Technology-Facilitated Abuse

This theme examines victims' experiences in hybrid online-offline environments, including stalking, bullying, and privacy violations. It also focuses on trauma, secondary victimisation, and the challenges of handling digital evidence in victim-centred processes.

12. Human Rights, Ethics, and Constitutionalism in the Digital State

This theme reflects on the tension between security governance and rights-based constitutional protections. It explores privacy, proportionality, transparency, and explainability as essential safeguards in a technology-driven criminal justice system.

13. Governance, Data Regulation, and Institutional Accountability

This theme focuses on state capacity, administrative design, and public-private partnerships in digital policing and security infrastructure. It examines regulatory gaps, data governance challenges, and the need for transparent oversight mechanisms.

14. Community Resilience, Alternatives to Punitive Digital Control, and Decolonising Justice

This theme explores community-led responses, restorative justice models, and transformative alternatives that counter punitive and technologically driven control. It also invites southern and decolonial perspectives on digital governance and criminal justice reform.

15. Future Risks, Emerging Technologies, and Structural Digital Harms

This theme focuses on the risks posed by quantum technology, deepfakes, algorithmic discrimination, and platform economies. It welcomes scholarship on new structural harms, digital vulnerabilities, and the evolving socio-economic landscape of crime.
